Group Chair Report

As we reach a milestone of 65 years of Scouting in Denmead, it gives me great pleasure to report back to you all that it has been another fantastic year.

As the Executive Committee (Group Trustees) it is our collective responsibility to look after the running and governance of the Group from events, facilities (Scout HQ), assets (trailers, camping equipment) and the finances. The Trustees support helps our leaders and other volunteers run the Scout programme that gives your young people skills for life.

At 1st Denmead we are very lucky to have an amazing collective of Trustees, Leaders and volunteers. I'd like to thank all the Executive team for their support throughout my first year as Group Chair.

It has certainly been a busy year for the team, strengthening our relationships with the community and I'd like to report back on some of our key activities this past year:

- **Dinosaur Derby** after a couple of years break, due to Covid19, our biggest fundraising event of the year was back. It was very well attended with visitors from over 25 miles away coming to support our Group which raised approx. £5000.
- New Scout HQ Project the Group has been for the past few years looking at the need to replace our current Scout HQ building, it has served the Group well for nearly 30 years but needs to be replaced. I am proud to say, over the past 12 months, we have officially engaged Denmead Parish Council and Winchester County Council planning team and have taken our first steps.
- New Scout HQ Lease Agreement in conjunction with the new Scout HQ project, we have started conversations with Denmead Parish Council to revise and extend our long term lease agreement, providing security to the Group for years to come.
- Busy Bees Nursey the Group is very lucky to have Busy Bees Nursey using the Scout HQ during the day and we have agreed a new 3 year long term hire agreement with them this year.
- Charities Commission Application the Group, as part of the Scouts Association, has charity status by default but this year the Group have started to take the necessary steps to be a registered charity in its own right.

- Denmead Parish Council the Group continues to strengthen its relationships within the
 community and this year, given the ongoing activities, Denmead Parish Council agreed for our
 request to align two Parish Cllrs (Brown and Walsh) to act as Scout Liaison officers to provide
 support.
- New Website as I hope many of you have seen, we have invested into a brand new website to
 provide up to date information and advertise the Group. Unfortunately during this project we
 unexpectedly and sadly lost a friend and supporter of the Group, Mark Woodroof, who had hosted
 our website for many years. Our thoughts continue to go out to his family and friends.

The Group continues to be in good financial health with a whole range of fundraising events happening over the past year. Group Treasurer, Pam Allsop-Smith, will shortly take you through the details and be able to answer any questions.

As I hope you can see and agree with me that the team have bounced back from a couple of challenging years related to Covid19 and are doing amazing job. Again I'd like to thank Tracy, the leaders, volunteers and Committee for all they have done this year.

Group Scout Leader Report

This report provides an overview of some of the activities and accomplishments of 1st Denmead Scout Group.

We currently have 108 youth members across 3 Beaver Colonies, 2 Cub Packs and 1 Scout Troop.

We have awarded an impressive 516 badges across all 3 sections with **3 Bronze Awards** in Beavers and **4 Silver Awards** in Cubs. These are the highest awards the young people can achieve in their sections and we are very proud of their achievements.

Every year we try to offer at least 1 sleepover or camp for each section and in the last year:

- Beavers have had 2-night medieval sleepover
- Cubs enjoyed a medieval weeklong camp at the land of nod
- Scouts spent 2 nights at the Spring ahead camp as part of a district camp

Alongside our weekly section meetings, where we work on badges and through fun, exciting activities we provide skills for life, the team also run extra activities where possible.

- Beavers they have visited Waterlooville fire station and had a visit from the Police Educational
 team. They have enjoyed a performance of The Snow Queen at Denmead Memorial Hall. A
 morning was enjoyed at the Royal Armouries and of course the group visited Marwell Zoo. Beavers
 also said a big thank you to their special person as part of their mother's day and father's day
 celebrations, with a coffee morning featuring biscuits and chocolates made by the Beavers.
- Cubs- they have been working hard on their badges building shelters in the woods, learning to
 pack a bag for camp, making vegetable moveable cars, Christmas cake making and hiking, to name
 only a few of their activities.

• Scouts - ever wondered what it would be like to play Monopoly in real life? 12 of our Scouts competed against other groups from the old Havant and Waterlooville district. The event was open to Scouts from across the UK who competed in games of up to 7 teams, visiting the streets in the London monopoly board, buying properties, paying rent, and completing team challenges. Denmead Scouts won their group with 1 of the Scouts being invested on the tube, what a great place to officially become part of the scout association!

None of this is possible without all the leaders, assistant leaders, supporters, and Trustee committee. All these people work hard to provide your children with a varied weekly programme, camps, and days out and I thank them all.

We have been working hard supporting our Ex-Scouts, who are now Explorers, with raising funds for their international adventures, thank you to everyone who has attended the fundraising events. We have 1 attending the World Scout jamboree in South Korea with 4 more attending Project 23 which is a 3 week tour of Europe in August. We look forward to hearing about their adventures.

As you will all be aware, for a variety of reasons, we have lost some of our leaders in the last year so we need to recruit some new volunteers for all sections. A massive thank you to those who have already stepped forward to volunteer. If you think you might like to give it a try and join the fun, please do speak to me or any of the leaders. We offer flexible volunteering, so you don't need to commit to every week.

Some of you will be aware that we merged districts this year and we are now officially know as the HAWKS District, this brings together Waterlooville and Havant districts. The merger will enable bigger district events and the ability to pull resources from a larger area. At a Group level we shouldn't see much change apart from a new badge which is currently in production. Some of the cubs entered a competition to design the new badge with the final design an amalgamation of several designs. Congratulations to Thomas D who designed the sun and hills part of the new badge and won a small prize.

All our leaders must commit to training and on-going learning, safety, safeguarding and first aid are completed every three years. Without these modules being in date a leader cannot remain in their role. I hope this offers you as parents' reassurance that the safety and well-being of you children is our top priority. Additionally, some of the leadership team have attended a neurodiversity workshop which provided a valuable insight as to how we can adapt our programme, so we are truly striving to be inclusive for all.

Finally, a big part of our ethos is to be present in our community were we have run a variety of events including:

- The biggest event in Denmead, Dinosaur Derby, which raises valuable funds for the Group
- All Saints kindly let us use their car park for the Christmas Carols where was raised money for Sailability
- We also organise the village Remembrance parade along with the church and DPC.
- We have also cooked Smores at the coronation celebrations
- And of course attended many events with the trolley run
- Thanks to Ange and the recycling team we are still recycling plastic waste, bras, toothbrushes to name a few, reducing the amount of waste that goes to Landfill.

As we look towards the future, we hope to bring Squirrels to the Group in the New Year. Squirrels are the newest and youngest section within the Scout Association, aged 4-6 years old. Of course, this will only be possible with volunteer support.

Over the next few years we will raising funds for our new HQ building as Kev has already mentioned. Please support us by attending one of our events, Bingo Ben will be back as will the quiz and camel racing nights and who can forget our swishing night where clothes are saved from the bin!

Thank you everyone for your ongoing support. We can only grow and continue to be successful with volunteers so if you think you want to join the adventure, please speak to me or any of the leaders.
